



## Minutes of the Extraordinary Meeting of Hilton Parish Council on Monday 19<sup>th</sup> January 2026 at 19:00 in Hilton Methodist Church Hall

25/26-191. To receive any apologies for absence.

Apologies were received from Cllr J. Capes.

C.Cllr Keane drew attention to his written report made available earlier in the month. He highlighted the subsequent decision of HDC to advise to the Secretary of State it can manage elections in May 2026 alongside the work associated with Local Government reorganisation. It was confirmed that local Parish Council elections will proceed in 2026 whether or not elections occur at District and County levels.

19.07 Meeting reconvened.

25/26-194. To note the current contract with Yu Energy for unmetered supply of electricity for street lighting expires on 29<sup>th</sup> January 2026, consider new quotations and decide any actions.

It was **RESOLVED**, with two Cllrs abstaining, that Hilton Parish Council enter a one-year contract with Valda Energy based on a daily standing charge of £0.75 and a unit rate of £0.39 p/kwh.
