



Minutes of the Extraordinary Meeting of Hilton Parish Council on Tuesday 18th August 2026 at 18:45 in Hilton Methodist Church Hall

Present: Cllr P. Balicki, Cllr R. Norton, Cllr M. Stott, Cllr S. Suckling.

In attendance: The Clerk (N. di Castiglione), District Cllr N. Sarkies.

Meeting commenced 18.48.

26/27-101. To receive any apologies for absence.

Apologies were received from Cllr R Dulstone (otherwise engaged), Cllr E. McCarthy (work), and Cllr C. Wood (holiday).

DCllr Sarkies gave an update on matters relating to Huntingdonshire DC: Local Government Reorganisation – no decision as yet and not likely before October; the Local Plan has been updated but details are still to be published; plans to redevelop central car park facilities in St Neots, Huntingdon and St Ives have generated a high volume of concern.

The meeting was reconvened at 19.01.

26/27-104. To consider planning consultation received and agree any response, Redwoods, The Green PE28 9NA: TREE Application Ref.26/01397/TREE > T1-T2 Lime trees – remove, > G! reduce the overhang to give a 2-meter clearance between house and treeline; > T3 Sorbus tree – remove.
